1. Expenditure is incurred only on sanctioned works (NHs and State Roads) in LWE affected area only.
2. No claim is entertained for expenditure incurred on any sanctioned works in excess of the sanctioned cost beyond permissible limits.
3. No expenditure is admitted on work/portion of the work where it might have been specifically advised not to incur any expenditure pending receipt/approval of certain issues/points, etc.
