In continuation of this Ministry's letter no. G-23011/04/2026-W&A dated 28th April, 2026, I am directed to convey the sanction of the President to release of fund amounting to Rs.5300.00 Crore (Rupees five thousand three hundred crore only) to National Highways Authority of India for investment under Major Head 5054 for the F. Y. 2026-27 as under:-

2. The above expenditure is debitable to the following head under Demand No.86 - Ministry of Road Transport & Highways for the year 2026-27:-

3. There is total BE provision of ₹ 73921.58 crore under NH(O)-General from GBS for the financial year 2026-27. Out of which Rs.15,303 crore has been allotted to State PWD, Rs.990 crore has been allotted to NHIDCL and Rs.70 crore has been allotted to BRO. After release of this amount of Rs.5300.00 crore [total: Rs.14,000 crore] to NHAI, an amount of ₹43,558.58 is reserve/balance in the head of account.

4. It shall be ensured that the expenditure against above sanction is incurred only on the NH works entrusted to NHAI by the Ministry.

5. Compliance of the provisions of OM (F.No.12(13)-B(W&M)/2020) dated 25.05.2022 issued by Budget Division, Department of Economic Affairs, Ministry of Finance, has been ensured.”.

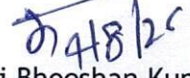

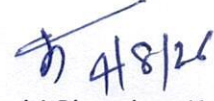
