SUB: Four laning of Ahmedabad to Godhra Section of NH-47 from Km. 4.200 to 122.420 in the State of Gujarat on DBFOT Basis under NHDP Phase-III.

- Proposal seeking ROW permission for laying proposed 8" Dia Steel Gas Pipeline with 125mm PE Gas Pipeline and 125mm PE Gas Pipeline along NH-47 at from Km 5+345 to Km 10+811 (RHS), from Km 10+811 to Km 12+390 (LHS) and crossing at Km 8+900 and Km 11+980 on Ahmedabad-Godhra section of NH-47 from Singrava to Kujad in Ahmedabad and its surrounding areas of Ahmedabad GA in the state of Gujarat.

Adani Total Gas Limited, Ahmedabad vide their office letter u/ref.(2), in compliance to PD, PIU-Ahmedabad office letter u/ref.(3), seeking ROW permission for laying proposed 8" Dia Steel Gas Pipeline with 125mm PE Gas Pipeline and 125mm PE Gas Pipeline along NH-47 at from Km 5+345 to Km 10+811 (RHS), from Km 10+811 to Km 12+390 (LHS) and crossing at Km 8+900 and Km 11+980 on Ahmedabad-Godhra section of NH-47 from Singrava to Kujad in Ahmedabad and its surrounding areas of Ahmedabad GA in the state of Gujarat.
