- SUB: Two Lane with paved shoulder of Padhi-Dahod section of NH-113 (New NH-56) from Km. 180+000 to Km. 267+000 (Design Ch. 180+000 to Ch. 265+588) [Design Length 85.588 Km] under NHDP Phase-IV in the state of Rajasthan and Gujarat on EPC Mode:
  - Proposal seeking ROW permission for crossing NH-113 at Km 238+086 between Jhalod to Dahod section near Village-Limdi for laying Drinking Water Supply Pipeline, Taluka Jhalod, District Dahod in the state of Gujarat.
