Sub: Rehabilitation and up-gradation to 2-lane with paved shoulder for Jind-Karnal section from existing km 68+660 (Design km 68+857)i.e junction with Narwana Road (NH-352) at Subhash Chow kana ends at km. 153+700 (Design 154+219) at ITI Chowk which is the intersection with NH-1 of NH 709 A in the State of Haryana under NH (O) (Package-II)-Proposal for laying of 900mm diameter RCC pipe from Km 0.700 to Km 2.786 by trenchless technology, crossing of box drain at Km 0+700 by open cut method and crossing of RCC pipe of 600mm at Km 1+520 to 1+540 by open cut method in NH-709A i.e. Karnal-Meerut Road in Karnal Town in the State of Haryana.
