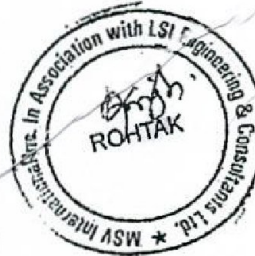

Jhajjar, Haryana	The provisional certificate for the same was issued on 03.04.2017 and EOT were granted by RO Chandigarh upto 01.04.2019 vide letter of RO MoRTH dated 19.07.2018. The agency requested for final approval vide its letter dated 29.03.2019. However, the same was not accorded by PIU Rohtak in terms of its observations. The IE has certified that the work has been completed. Earlier, the recommendation by IE & PIU-Rohtak was not made due to certain observations & its compliances which were not done in time. Subsequently the covid outbreak made further delay. Therefore, the relaxation is sought by applicant for which IE has also recommended in the light of MoRTH guidelines vide Circular dated 26.06.2020	Though the work was completed by agency however, certain observations and its compliances could not be fulfilled due to some contingent issues and subsequently due to covid pandemic outbreak, it appears justified for extending relaxation for final approval.
