INVITATION OF PUBLIC COMMENTS

Sub:- NHAI-RO Kerala- Six Laning of Kodunagllur to Edapally section of NH-66(old NH-17) from Des.Ch.397+750(Ex.Ch.411+850) to Des.Ch.423+780(Ex.Ch.343+330) in the State of Kerala on HAM under Bharatmala Pariyojana -Laying of PLB pipes/OFC cable through HDD by M/s BSNL from Km 413+700 to Km 414+600 (RHS) of NH-17(New NH-66) in the State of Kerala-Reg.

The proposal is regarding permission sought by M/s BSNL for laying of PLB pipes/OFC cable through HDD by BSNL from Km 413+700 to Km 414+600 (RHS) of NH-17(New NH-66) along the subject project stretch in the State of Kerala.

2. M/s BSNL has furnished undertaking to shift the OFC cable at their own cost at an alternate location whenever NHAI make a request for shifting of the same. Further, the applicant has undertaken for confirming with all standards as mentioned in the Ministry's Circular.

3. Further, M/s BSNL has undertaken that they will not damage any other utility during the process on laying and in case, if damaged, then to pay the losses either to NHAI or to the agency concerned. Further, M/s BSNL has undertaken to bear the expenditure incurred by NHAI for repairing any damages caused to the NH by laying, maintenance or shifting of the proposed water supply line.

4. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by M/s BSNL will be made available for 30 days seeking public Comments/objections and the comments shall be furnished within 30 days from the day of closure of public objections.
