### INVITATION OF PUBLIC COMMENTS

Sub:- NHAI-RO Kerala-Four Laning of Thuravoor (Km.379+100) to Paravoor (Km.417+000) section of NH-66(Old NH-47) in the State of Kerala on EPC Mode under Bharatmala Pariyojana- Laying of Natural gas pipeline from Km.386+082 to Km.386+130(LHS), Km.386+130 to Km.386+310(RHS) and Crossing of Natural gas pipeline at Km.386+130 by M/s AG&P City Gas Pvt.Ltd. -Reg.

(MoRTH Application Ref. No.20230119/1/12/18230/1978)

The proposal is regarding permission sought by M/s AG&P City Gas Pvt.Ltd. for laying of natural gas pipeline from Km.386+082 to Km.386+130(LHS), Km.386+130 to Km.386+310(RHS) and crossing of natural gas pipeline at Km.386+130 in the subject project stretch in the State of Kerala.

2. M/s AG&P City Gas Pvt.Ltd. has furnished undertaking to shift the underground Pipeline at their own cost at an alternate location whenever NHAI or any other road authorities make a request for shifting of the same. Further, the applicant has undertaken to confirm with all standards as mentioned in the Ministry's Circular No. RW/NH-33044/29/2015-S&R dated 22.11.2016.

3. Further, M/s AG&P City Gas Pvt.Ltd. has undertaken that they will not damage any other utility during the process on laying and in case, if damaged, then to pay the losses either to NHAI or to the agency concerned. M/s AG&P City Gas Pvt.Ltd. has also undertaken to manage traffic movement during the execution of the work.

As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by M/s AG&P City Gas Pvt.Ltd. will be made available for 30 days seeking public Comments/objections and the comments shall be furnished within 30 days from the day of closure of public objections.
