### INVITATION OF PUBLIC COMMENTS

**Sub: NHAI, RO-Kerala - Six Laning of Azhiyur to Vengalam section from Ch. 189.200 (existing km 188.000) to Ch. 232.100 (existing Km 230.400) (Total length 40.8 km) on Hybrid Annuity Mode under Bharatmala Pariyojana in the State of Kerala-Permission for Laying 3\*300 sq.mm XLPE UG Cable through a 110mm dia HDPE pipe (90 m) at Design Ch. 210.050-Reg**

The proposal is regarding permission sought by Kerala State Electricity Board (KSEB) Ltd. vide letter No, PMU-VDK/20-21/83 dated 22.01.2021 for permission for laying 3\*300 sq.mm XLPE UG Cable through a 110mm dia HDPE pipe (90 m) at Design Ch. 210.050 by HDD Method in the Azhiyur to Vengalam road section of NH-66 in the State of Kerala.

2. The said location is in Payyoli village of Koyilandy Taluk in Kozhikode District.

3. M/s. KSEB has furnished an undertaking to shift the utility service as and when required by NHAI at their own cost at an alternate location whenever NHAI make a request for shifting of the same. Further, KSEB has undertaken to confirm with all standard conditions in the Ministry's Circular No. RW/NH-33044/29/2015-S&R dated 22.11.2016.

4. Further, KSEB has undertaken that they will not damage any other utilities during the process on laying and in case, if damaged, then to pay the losses either to NHAI or to the agency concerned. Further, KSEB has also undertaken to ensure management of traffic movement during laying of utility line and not to hamper the movement of traffic.

5. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by KSEB will be made available for 30 days seeking public Comments/objections and the comments shall be furnished within 30 days from the day of closure of public objections.
