INVITATION OF PUBLIC COMMENTS

Sub: NHAI, RO-Kerala - Six Laning of Neeleshwaram to Thaliparambha section from Ch. 94+540 (existing km 96+450) to Ch. 134+650 (existing Km 137+900) (Total length 40.11 km) on Hybrid annuity Mode under Bharatmala PariyojAna in the State of Kerala - **Permission for Laying 90mm PVS pipe(4550 m) and 200mm DI K9 pipe(120 m) from Existing Ch. 115/250 to 117/710-Reg**

The proposal is regarding permission sought by Kerala Water Authority (KWA) vide letter No. D2-576/2020 dated 13.11.2020 for laying 90mm PVS pipe(4550 m) and 200mm DI K9 pipe(120 m) from Existing Ch. 115/250 to 117/710 of Neeleshwaram to Thaliparambha section in the State of Kerala.

2. The said location is passing through survey numbers 34,35,43,52,63,64,90,89,88,86 & 121 in Kunhimangalam village, Edanand Desom at Kannur Taluk.

3. KWA has furnished an undertaking to shift the utility service as and when required by NHAI at their own cost at an alternate location whenever NHAI make a request for shifting of the same. Further, KWA has undertaken to confirm with all standard conditions in the Ministry's Circular No. RW/NH-33044/29/2015-S&R dated 22.11.2016.

4. Further, KWA has undertaken that they will not damage any other utilities during the process on laying and in case, if damaged, then to pay the losses either to NHAI or to the agency concerned. Further, KWA has also undertaken to ensure management of traffic movement during laying of utility line and not to hamper the movement of traffic.

5. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by M/s. KWA will be made available for 30 days seeking public Comments/objections and the comments shall be furnished within 30 days from the day of closure of public objections.
