SUB: Construction of six lane access controlled Greenfield Highway from Km. 4+888 to Km35+000 of Rajasthan/Gujarat Border to Santalpur section of NH-754K as a part of Amritsar Jamnagar Economic Corridor in the state of Gujarat on EPC mode Under Bharatmala Pariyojana(Phase-01) (AJ/RGBS/Package-1).
