**Invitation of public comments**

**Subject:-** Permission for access to proposed Retail outlet of oil company (HPCL) abutting on NH-58 at chainage Km 158/545 ( between chainage Km 158/435 to Km 158/555) , Survey No.76,79,80,81,82/89 right hand side at village Palanpur , Taluka Palanpur, District Banaskantha in the state of Gujarat

The instant proposal was granted provisional NOC vide this office letter of even number dated 10.03.2016 which was further extended upto 10.03.2018.

2. The proposal for final access permission dated 01.12.2017 was forwarded to EE, NH division, Ahmedabad vide letter dated 15.01.2017 for his examination and submission of completion certificate. Accordingly, PWD vide letter No. NHP-11-2018-1592-M dated 08.08.2018 submitted final completion certificate. Mean while the period of two years from issue of provisional NOC was also completed and as per Ministry's guidelines No.RW/NH-33023/19/99/DO-III dated 24.07.2013 and its amendment dated 01.12.2014 the validity of provisional NOC was expired.

3. It is noted from the recommended proposal of PWD that between this period the validity of registration of empanelled consultant of access permission was expired. For this period no extension was given to any empanelled consultant of the Ministry and without certification of empanelled consultant the concerned EE could not issue the completion certificate.

4. The oil company vide letter dated 30.08.2018 informed that this delay beyond 2 years is due to departmental procedures and non-extension of validity of empaneled consultant and asked to consider the for relaxation against time deviation as per guidelines circulated vide letter no. RW/NH-33023/19/99-DOIII dated 16.03.16.

4. In view of the above, comments of public for relaxation against time deviation, if any, on the above mentioned proposal is invited on below mentioned address/ Email address.
