The Project Director, PIU - Visakhapatnam submitted a proposal APEPDCL, Operation Circle, Visakhapatnam for laying of 33KV & 11KV underground Electrical Cable along the highway from Km.674+400 to Km.694+600 (RHS), and from Km.694+600 to Km.700+920(LHS) for a total length of 26520 meters & crossing in 27 locations for a length of 1620 meters in section of six laning of Ranasthalam - Anandapuram, Six laning of Anandapuram-Pendurthi-Anakapalli & Anandapuram - Visakhapatnam - Anakapalli (city limits) section of NH-16 in the State of Andhra Pradesh.

Vide ref.01 cited above APEPDCL has submitted the proposal for laying of Underground electrical cable along the NH-16 from @KM 674+400 to @KM 694+600(RHS), and from @KM 694+600 to @KM 700+920(LHS) for a total length of 26520 metres & crossing in 27 locations for a length of 1620 metres in sections of six lanining of Ranasthalam Andapuram -, Six laning of Anandapuram-Pendurthi-Ankapalli & Anandapuram-Visakhapatnam-Ankapalli(city limits) section of NH-16 in the state of Andhra Pradesh.

- 2. The proposal was forwarded to the Independent Engineer's of all three stretches vide this office letter  $2^{nd}$ ,  $8^{th}$  &  $12^{th}$  cited for recommendations and feasibility. The Independent Engineer's has inspected the site and recommended the above proposal vide ref  $04^{th}$ ,  $13^{th}$  &  $14^{th}$  cited. Moreover, concessionaire's M/S DBL and M/S Ashoka has also submitted their consent to the proposal vide ref  $15^{th}$  &  $16^{th}$  cited.
- 3. The following documents are submitted by the Agency as per the MORTH guidelines dated 22.11.2016.
  - (a) Proposal letter.
  - (b) Check List.
  - (c) Specification Report to accompanying the estimate towards License Fees for Laying of OFC cable.
  - (d) License Fees Estimate.
  - (e) Agreement regarding granting of Right of Way permission.
  - (f) Undertaking for Performance Bank Guarantee.
  - (g) Certificate for Six Lanning,
  - (h) They have given Affidavit to take all the actions as prescribed in the Check List from 5.1 to 5.12.
  - (i) Format for maintain records of ROW permission granted for laying OFC.
  - (j) Brief description of Horizontal Directional Drilling Method and Open trench method.
  - (k) Cross section & Strip plan.
- 4. Out of total length of 26.52kms proposed for laying of underground power cable about 18kms falls on NH-16 passing through the Visakhapatnam city limits. The DPR for construction of grade separators at various locations on NH-16 from KM 682+950 to KM 741+256 passing through Visakhapatnam city limits is under progress. However, APEPDCL has submitted an undertaking stating that "We do undertake that i/we relocate service road/approach road/utilities at my/our own cost notwithstanding the permission granted within such time as will be stipulated by NHAI for future six laning or any other development".
- 5. In view of the recommendations of the Consultants, the proposal submitted by APEPDL for laying Underground Electrical Cable along the highway from @KM 674+400 to @KM 694+600(RHS), and from @KM 694+600 to @KM 700+920(LHS) for a total length of 26520 metres & crossing in 27 locations for a length of 1620 metres in sections of six lanining of Ranasthalam -Andapuram , Six laning of Anandapuram-Pendurthi-Ankapalli & Anandapuram-Visakhapatnam-Ankapalli(city limits) section of NH-16 in the state of Andhra Pradesh, is herewith recommended for the approval of Competent Authority.
