Invitation of Public Comments

Sub: NHAI, PIU, Coimbatore - Rehabilitation and Up-gradation of NH-209 (new no. NH83) from km 123.550 to Km. 150.400 of Dindigul - Bangalore Road (Pollachi to Coimbatore Section) to four lane with paved shoulder in the State of Tamilnadu under NHDP-IV on EPC Basis - *Request for Approval of Laying AMRUT 2.0 2022-2023 - Improvements of water supply Scheme to Othakalmandapam Town Panchayat, Othakalmandapam, Coimbatore District - Laying Underground Water Pipe Line along the extreme end of NH boundary between 140 mm Ø HDPE pipe K.M. 143/200 to 144/800 (LHS), 140 mm Ø HDPE pipe K.M. 143/200 to 144/610 (RHS) of Dindigul Palani Pollachi Coimbatore Road Section (NH-209), Coimbatore District, Tamilnadu State - Reg.*

1. The proposal is regarding permission for laying Optical Fibre Cable (OFC) on NH-209 road, new pole installation along the road (29 nos) for laying Underground Water Pipe Line along the extreme end of NH boundary between 140 mm Ø HDPE pipe K.M. 143/200 to 144/800 (LHS), 140 mm Ø HDPE pipe K.M. 143/200 to 144/610 (RHS) at Pollachi - Coimbatore section.
2. The Executive Officer, Othakalmandapam Town Panchayat, Coimbatore District has furnished an undertaking to accept any claims raised by the Authority, if any and the same will be paid by them and also furnished undertaking not to damage other utility, if damaged, then to pay the losses either to NHAI or to the concerned agency.

As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/ S&R(R) dated 22.11.2016, the proposal submitted by M The Executive Officer, Othakalmandapam Town Panchayat, Coimbatore District will be made available for 30 days seeking public comments/objections and the comments shall be furnished within 30 days from the day of closure of public objections.
