- Sub: NHAI PIU, Salem Proposal for laying proposed 16" dia multi product pipeline with OFC Duct along the road on NH-44 from Km 142.074 to Km 156.000 (RHS) & Km 164.900 to Km 180.000 (RHS) for a total length of 29.026 Km (Krishnagiri to Thumbipadi section) by Open Trench Method in the limit of NHAI, Salem by M/s Bharat Petroleum Corporation Limited, Chennai - Approval requested – Reg
- 1). The subject proposal is requesting permission for laying proposed 16" dia multi product pipeline with OFC Duct along the road on NH-44 from Km 142.074 to Km 156.000 (RHS) & Km 164.900 to Km 180.000 (RHS) for a total length of 29.026 Km (Krishnagiri to Thumbipadi section) by Open Trench Method in the project of Krishnagiri to Thumbipadi section of NH-44 in the State of Tamil Nadu.

M/s Bharat Petroleum Corporation Limited, Chennai has furnished an undertaking to move the utility line for any work of improvement or repairs to the road, if NHAI considers if necessary in future, it will be carried out as desired by the NHAI at their cost within a reasonable time (not exceeding 90 days) of the intimation given. Further, the applicant has furnished the undertaking for payment of rent / fee as mentioned in the Ministry's Circular No.RW/NH-33044/29/2015-S&R dated 22.11.2016 as when asked by NHAI.
- **3).** As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by M/s.Bharat Petroleum Corporation Limited, Chennai will be made available for 30 days seeking public comments / objection and shall be furnished within 30 days from the day of closure of public objections.
