**Permission for grant of approval for laying of Water Supply Utility under the Bokhara Water Supply Scheme, Tah & District Nagpur -Reg.**

It is to inform all concern that M/s Maharashtra-Jeevan Pradhikaran (MJP) vide letter under reference (ii) has submitted a proposal for the subjected work and PD, has recommended the above proposal vide letter under reference (i) for approval of the Competent Authority / Highway Administrator.

2. The alignment proposed by that MJP, Nagpur along on Nagpur- Betul Section of NH-47 (Old NH-69) in the State of Maharashtra is as follows:

- Laying of water pipeline from km 6.869 to 7.465, km 7.666 to km 7.854 & km 8.822 to km 8.910 along the service road LHS and km 8.122 to 8.822 along the service road RHS and km 7.465 to km 7.621 & km 7.854 to km 8.122 along service road BHS through Open Trenching.

3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
