Executive Engineer, MSEDCL, Dhule vide letter cited above has submitted Proposal for Crossing of Underground 33 KV XLPE Electrical Cable across with (Dhule-Pimpalgaon Section) of NH-3 for approval of the Competent Authority, Highway Administration.
