With reference to the above subject, the proposal for laying of water supply pipe line at 3 locations "1. Laying of water pipe line of 350mm dia casing MS pipe and 280mm dia carrying HDPE pipe at km: 142.900 of NH-275, near Kundanahalli Circle of Periyapatna Taluk , 2. Laying of 1200mm dia casing MS pipe and 900mm dia carrying MS pipe, at Km: 141.500 of NH-275 , near Alanahalli gate of Periyaptana Taluk, 3. Laying of 400mm dia casing MS pipe and 315 mm dia carrying MS pipe at Km: 160.700 of NH-275, near Chilkunda Village of Hunsur Taluk by HDD method in Mysuru District in the State of Karnataka" for lifting of water from Cauvery river near Muthinamulasoge Village to fill 133 tanks and 17 katte of 79 villages in Periyapatna & Hunsur Taluk, Mysore district was submitted by the Executive Engineer, Cauvery Neeravari Nigam Ltd., Harangi Rehabilitation Division, Kushalanagara, Mysuru. The Assistant Executive Engineer, NH sub division, Mysore vide letter cited at above reference has submitted the proposal.

The proposal is herewith examined in light of Ministry Circular no: RW/NH-33044/29/2015/S&R(R) dated: 22.11.2016 and latest amendment no: NH-36094/01/2022-S&R(P & B) dated: 17.04.2023.

The License Fee as per the Ministry Circular dated: 17.04.2023, which works out to **Rs. 56,400** for 5 years. Further, the Cauvery Neeravari Nigam Ltd., Department is ready to deposit the Licensee fee and the Bank Guarantee as per the norms of the Ministry. Since, the said works involves the larger public interest and it's a major project wherein which it has been intended to fill Cauvery water to 133 tanks and 17 katte of 79 villages villages in Periyapatana & Hunsur Taluk.

Hence, the proposal for laying of Water Supply Line crossings at Km: 142.900, 141.500 & 160.700 of NH-275, Bantwal- Bangalore by using HDD method along with the draft agreement, check list, necessary undertaking and licensee fee calculation are here with submitted for obtaining concurrence from the Competent Authority at the earliest.

It is here by requested your kind self to communicate the NOC for laying of water pipeline as the earliest as the work is of prime importance.
