## **INVITATION OF PUBLIC COMMENTS**

Sub:- NHAI-RO Kerala-Four Laned Kazhakuttam to Mukkola section (Km.0+000 to Km.26+500) of NH-66 in the State of Kerala under NHDP Phase-III on EPC mode-Crossing of 11 KV 3C x 300 Sqmm HT Cable though HDD by M/s Kerala State Electricity Board (KSEB) at Km.6+760 of NH-66 (Thiruvananthapuram Bypass)- Reg.

यह प्रस्ताव मेसर्स केरल राज्य विद्युत बोर्ड (KSEB) द्वारा एनएच-66 के किमी 6+760 पर एचडीडी के माध्यम से 11 केवी 3C x 300 Sqmm एचटी केबल को क्रॉसिंग के लिए मांगी गई अनुमति के संबंध में है।

The proposal is regarding permission sought by Kerala State Electricity Board for crossing of 11 KV 3C  $\times$  300 Sqmm HT Cable through HDD at Km.6+760 of NH-66 (Thiruvananthapuram Bypass in the State of Kerala.

- 2. KSEB has furnished undertaking to bear all expenditure, if any, incurred by NHAI for repairing any damage caused to NH by laying, maintenance or shifting of UG cable. Further, the applicant has undertaken to confirm with all standards as mentioned in the Ministry's Circular No. RW/NH-33044/29/2015-S&R dated 22.11.2016.
- 3. Further, KSEB has undertaken that they will not damage any other utility during the process on laying and in case, if damaged, then to pay the losses either to NHAI or to the agency concerned. KSEB has also undertaken to manage traffic movement during the execution of the work.
- 4. As per the guidelines issued by the Ministry vide letter No.RW/NH33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by KSEB will be made available for 30 days seeking public Comments/objections and the comments shall be furnished within 30 days from the day of closure of public objections.
