Water Supply Pipeline from Km. 0.000 to Km. 2.000 (LHS), Km. 2.000 to Km. 3.408 (RHS) along NH-160A (Length 3.408 Km) & 01 Crossing at Km. 02.000 across NH-160A - Reg.

Chief Officer, Sinnar Nagar Parishad, Sinnar's vide letter cited above has submitted proposal for Laying / Crossing Water Supply Pipeline along / across with (Ghoti-Sinnar Section) of NH-160A for approval of the Competent Authority, Highway Administration.

- 2. From the submitted proposal, it is observed that, the Laying of Water Supply Pipeline is proposed from Km 0.000 to Km. 2.000 (LHS) & Km. 2.000 to Km. 3.408 (Total Length 3.408 Km) along NH-160A & 01 No. Crossing at Km. 2.000 across NH-160A.

As per Para-4 of Ministry of Road Transport & Highways (MoRT&H) Circular No. RW/NH-33044/29/2015/S&R(R), Dtd. 22.11.2016, the Highway Administration shall put out in the Public Domain for 30 days for seeking claims and objections (On grounds of Public inconvenience, safety and general public interest).
