

Sub: 6-laning of BarwaAdda - Panagarh section of NH-2 from Km 398.240 to Km 521.120 including Panagarh Bypass in the state of Jharkhand & West Bengal under NHDP Phase-V on BOT (Toll) on DBFOT pattern – Proposal for laying of underground 2 nos Gas pipeline of "Indian Oil Adani Gas Private Ltd." Along NH-19 (Old NH-2) in the stretches from; i) Km 451.915 to Km 461.900 (RHS), ii) Km 461.900 to Km 465.300 (LHS), iii) Km. 465.300 to Km 477.450 (RHS) & across NH-2 at Km 461.900 & Km 465.300, Dist- - PaschimMedinipur, West Bengal - Reg.

The Project Director, PIU-Durgapur, NHAI vide letter no: 15017 / 1 / 2013 / PIU (DUP) / IOAGPL / Prop5 / 7466 dated 29.06.2024 has submitted the subject mentioned proposal for granting licenses for use of National Highway land.
