INVITATION OF PUBLIC COMMENTS

Sub:- NHAI-RO Kerala-4 Laning of Walayar-Vadakkancherry from Existing km 182.250 to Km 240.000 in the state of Kerala under NHDP-Phase-III executed on BOT (Toll) on DBFOT Basis (Package NS-2/BOT/KL-2)-Laying of 450mm water pipeline from Km.209+075 to Km.209+653(LHS) of NH-544-Reg.

The proposal is regarding permission sought by Sh. S Shibukumar for laying of 450mm Water Pipeline through HDD from Km.209+075 to Km.209+653(LHS) of NH-544 along the subject project stretch in the State of Kerala.

- 2. Sh.S Shibukumar has furnished undertaking to shift the pipeline at their own cost at an alternate location whenever NHAI make a request for shifting of the same. Further, the applicant has undertaken for confirming with all standards as mentioned in the NHAI's guideline.
- 3. Further, Sh.S Shibukumar has undertaken that they will not damage any other utility during the process on laying and in case, if damaged, then to pay the losses either to NHAI or to the agency concerned. Further, Sh. S Shibukumar has undertaken to bear the expenditure incurred by NHAI for repairing any damages caused to the NH by laying, maintenance or shifting of the proposed water supply line.
- 4. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by Sh. S. Shibukumar will be made available for 30 days seeking public Comments/objections and the comments shall be furnished within 30 days from the day of closure of public objections.
