INVITATION OF PUBLIC COMMENTS

Sub:- NHAI-RO Kerala-Six Laning of Ramanattukara Junction to start of Valanchery Bypass section of NH-66 (Old-17) from Design Ch 258+818 (ex Km 27.840 of Kozhikode Bypass to Design Ch 298 + 500 (ex km 304.2450) in the state of Kerala on Hybrid Annuity Mode under Bharatmala Pariyojana-Accommodation of Public and Industrial Utility Service along National Highways-Laying of 3CX300 Sq.mm XLPE 11KV UG Cable through HDD from Km.261+980 to Km.264+140(RHS) and crossing at Km.264+140 by KSEB on NH-17(New NH-66)-Reg.

The proposal is regarding permission sought by Kerala State Electricity Board for laying/Crossing of 3CX300 SQMM XLPE 11KV UG Cable through HDD by KSEB from Km.261+980 to Km.264+140(RHS) and crossing at Km.264+140 along the subject project stretch in the State of Kerala.

- 2. KSEB has furnished undertaking to shift the UG cable at their own cost at an alternate location whenever NHAI make a request for shifting of the same. Further, the applicant has undertaken for confirming with all standards as mentioned in the Ministry's Circular.
- 3. Further, KSEB has undertaken that they will not damage any other utility during the process on laying and in case, if damaged, then to pay the losses either to NHAI or to the agency concerned. Further, KSEB has undertaken to bear the expenditure incurred by NHAI for repairing any damages caused to the NH by laying, maintenance or shifting of the proposed UG line.
- As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by Kerala State Electricity Board will be made available for 30 days seeking public Comments/objections and the comments shall be furnished within 30 days from the day of closure of public objections.
