Sub:- NHAI-RO Kerala-NH-66 Laying of 33KV 3CX300 SQMM XLPE UG cable through 150mm dia HDPE pipe along NH-66 from Ch Km280+277 to Ch 280+557(RHS) and across at Ch Km280+557 in Ramanattukara- Valanchery stretch by M/s KSEBL. -Reg.

The proposal is regarding permission sought by M/s KSEBL. 66 Laying of 33KV 3CX300 SQMM XLPE UG cablethrough 150mm dia HDPE pipe along NH-66 from Ch Km280+277 to Ch 280+557(RHS) and across at Ch Km280+557 in Ramanattukara- Valanchery stretchin the State of Kerala.

- 2. M/s KSEBL. has furnished undertaking to lay150mm dia HDPE pipeat their own cost and to shift at an alternate location whenever NHAI or any other road authorities make a request for shifting of the same. Further, the applicant has undertaken to confirm with all standards as mentioned in the Ministry's Circular No. RW/NH-33044/29/2015-S&R dated 22.11.2016 and amendment dt 24.04.2023.
- 3. Further, M/s KSEBL. has undertaken that they will not damage any other utility during the process on laying and in case, if damaged, then to pay the losses either to NHAI or to the agency concerned. M/s KSEBL. has also undertaken to manage traffic movement during the execution of the work.
- 4. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by M/s KSEBL.will be made available for 30 days seeking public Comments/objections and the comments shall be furnished within 30 days from the day of closure of public objections.
