(219.10 mm) steel carrier pipe through 12" dia. (323.8 mm) steel casing pipe of M/s Oil & Natural Gas Corporation. The proposed pipeline will be across National Highway NH-68 (Himmatnagar to Mehsana Highway) between Km 107/108 (Chainage No-107+907) Village - Kukas, Taluka - Mehsana, District - Mehsana, State - Gujarat.
