


Kindly refer to above mentioned letter under reference (i) on cited subject vide which M/s IOCL, Hazaribagh-Ranchi Pipeline Project, Ranchi has submitted permission for laying of 8.625 inch steel Gas pipeline along with OFC duct (63mm) across the NH-320B at Ch. 68.150.

Accordingly, this office vide letter dated 15.03.2024 had requested IE, M/s TPF Engg. Pvt. Ltd. in association with Rotrans Infra Project Pvt. Ltd to examine the said proposal in the light of MoRTH guidelines. M/s TPF Engg. Pvt. Ltd. in association with Rotrans Infra Project Pvt. Ltd vide letter dated 19.03.2024 has reviewed the proposal and reported that proposal is found in order and satisfying all requirements of Ministry Guidelines.

It is to intimate that that the said Gas pipe line is across the highway at km 68+150 (1-locations). The proposal has been examined with respect to ministry circular dated 22/11/2016 with following comments:

- Methodology has been submitted by the agency and for laying the utility across highway HDD method is proposed with Depth of pipeline below 1.5 meter minimum from natural ground level.
- The agency has submitted the undertaking that safety clearance from pollution control board and PESO (petroleum and explosive safety organization) will be submitted after obtaining clearance and cannot be submitted at this stage.
- In case of shifting of Pipe line in future while developing 6 lane or for any other case IOCL will shift/remove immediately the pipe line on its own cost without asking any reason from NHAI.
