Sub: Proposal for laying Natural gas pipeline 4" Dia Carboin Steel pipe by HSDD/Trenching (M/s Indraprastha Gas Limited) along the Shamli to Karnal Highways), NH-709A from ch. 67+440 to 68+000 (LHS) in total length=560 m in the state of Uttar Pradesh.

- M/s Indraprastha Gas Limited has submitted the Proposal for laying Natural gas pipeline 4" Dia Carbon Steel pipe by HSDD/Trenching (M/s Indraprastha Gas Limited) along the Shamli to Karnal Highways), NH-709A from ch. 67+440 to 68+000 (LHS) in total length=560 m in the state of Uttar Pradesh.
 - From the submitted proposal, it is seen that the laying of underground Gas Pipeline is Proposed at the Meerut-Karnal Highway (NH-709A).
 - 3. Applicant has Proposed Underground Gas Pipeline. The Work will be carried through HDD Methodology and through HDD Method only with the condition that embankment of the Highway should not be Damaged, and laying will be done at the edge of Row. Further, The agency while laying /maintenance of pipeline shall not cause any disruption to the traffic on the Highway. If there is crossroad / approach road connecting Highway, then at that particular location laying will be done only through HDD method. In case of crossings, work

should be executed strictly through HDD method.

- 4. As Per the guidelines, issued by Ministry vide Om no.RW/NH-33044/29/2015/ S&R(R) dated 22.11.2016, the application shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general Public interest).
- 5. In view of the above, comments of the public on the above application is invited to the below mentioned address, which should reach by this office within 30 days from the days from the date of publication beyond which on comments shall be entertained.
