Chief Manager (Project), M/s Neemrana II Kotputli Transmission Limited (N2KTL) submitted the proposal for permission of 400 KV AL-59 Quad Gurugaon (PG) - Sohna Road GPTL @ Neemrana II LILO Loop Out Line (N2KTL) over NH-148B (Paniyala - Alwar) between Ch. 15+500 - 15+600 near Village Babriya in District Kotputli-Behror in the State of Rajasthan.

2. From the submitted proposal, it is seen that the crossing at Km 15+538 is proposed for 400 KV AL-59 Quad Gurugaon (PG) - Sohna Road GPTL @ Neemrana II LILO Loop Out Line (N2KTL).
