The Proposal is regarding Permission for grant of access for Laying of underground gas pipeline along the road from Km. 49/560 to Km. 50/265 (RHS) (125 mm MDPE Pipe) and across the road at Km.49/560 (4" & 6" Carbaon Steel pipe) by HDD Method by M/s. AGP CGD India Pvt. Ltd in the Sriperumbudur to Karaipettai section of NH-48 in the state of Tamil Nadu.
