Invitation of Public Comments

Sub: NHAI, PIU, Viluppuram - Balance work of two laning with Paved shoulders of Tindivanam to Krishnagiri Section of NH66 from Km 37.600 to Km 219.782 under NHDP Phase III in the state of Tamil Nadu on Item Rate Contract - Request for permission to lay underground water pipeline along the road from Km.41/310 to Km.44/570 (RHS) and crossing at Km. 44/070 for a total length of 3290 m at the road of Tindivanam to Krishnagiri section of NH-77 (Old NH-66) - Approval requested-reg.

1. The subject proposal is requesting permission to lay underground water Pipeline along the road from Km.41/310 to Km.44/570 (RHS) and crossing at Km. 44/070 for a total length of 3290 meters in the project stretch of Tindivanam to Krishnagiri Section of NH-77 (Old NH-66) in the State of Tamil Nadu.
2. The Executive Engineer, TWAD Board, RWS Division, Kallakurichi has furnished an undertaking to move the utility line for any work of improvement or repairs to the road, if NHAI considers it as necessary, in future, it will be carried out as desired by the NHAI at their cost within a reasonable time (not exceeding 90 days) of the intimation given. Further, the applicant has furnished the undertaking for payment of rent / fee as mentioned in the Ministry's Circular No.RW/NH-33044/29/2015-S&R dated 22.11.2016 as when asked by NHAI.
3. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by the Executive Engineer, TWAD Board, RWS Division, Kallakurichi will be made available for 30 days seeking public comments / objection and shall be furnished within 30 days from the day of closure of public objections.
