### INVITATION OF PUBLIC COMMENTS

**Sub:** NHAI-PIU-NSK-Widening of existing 2 lane carriageway to 4/6 lane divided carriageway configuration for **Vadape-Gonde** (Km 539.5 Km 440) section of NH-3 in the State of Maharashtra- Proposal from Maharashtra Natural Gas Ltd.'s (MNGL) for laying Gas Pipeline along NH-3 from Km. 464.100 to Km. 440.000 total length 24.1 Km and 2 crossings at Km. 457.300 and Km. 461.700 across NH-3- Reg.

Maharashtra Natural Gas Ltd. vide letter cited above has submitted proposal for laying Gas Pipeline along NH-3 (Vadape-Gonde) section of NH-3 for approval of the Competent Authority, Highway Administration.

2. From the submitted proposal, it is observed that, the laying Gas Pipeline is proposed along NH-3 from Km. 464.100 to Km. 440.000 total length 24.1 Km and 2 crossings at Km. 457.300 and Km. 461.700 across NH-3.

3. As per Para-4 of Ministry Circular No. RW/NH-33044/29/2015/S&R(R), Dtd. 22.11.2016, the Highway Administration shall put out in the Public Domain for 30 days for seeking claims and objections (On grounds of Public inconvenience, safety and general public interest).
