Sub: NHAI-PIU-NSK- 4-laning of Sinnar - Shirdi Section of NH 160 from Design Ch: 0/000 to 50/943 including Sinnar Bypass of 3.375 km in the State of Maharashtra on Hybrid Annuity Mode - MSEDCL's Proposal for Laying of 11 KV HT Overhead Electrical Line on RSJ pole along NH-160 Total Length - 1.60 Km.

Maharashtra State Electricity Distribution Company Ltd.'s (MSEDCL), Rural Division, Nashik vide letter cited above has submitted proposal for Laying of 11 KV HT Electrical Line along NH-160 for approval of the Competent Authority, Highway Administration.

- 2. From the submitted proposal, it is observed that, the laying of 11 KV HT Overhead Electric Line is proposed along NH-160 (Sinnar Shirdi Section) within NHAI-ROW (Total Length 1.20 Km).
