Length 131.500 Km) in the State of Gujarat under NHDP Phase III through PPP on DBFOT Basis-Proposal seeking ROW Permission for Crossing & Parallel NH-53 by Laying of 11KV Under Ground cable line with 3CX240 sq.mm XLPE Power cable for Requirement of 11kv U/G cable line for new power demand at 11KV system voltage in respect to M/s Komal Industries Private Limited for proposed unit located At :- Mankepore, Ta:- Bardoli, Dist. :- Surat with 3Cx240 Sq.mm. (1+0) XLPE cable, Crossing to NH-53 chainage 74.945 KM and parallel between chainage KM 74.945 to 76.345, Proposed Solar Plant under work.


