Sub: NHAI-PIU-NSK-Widening of existing 2 lane carriage way to 4/6 lane carriageway configuration for Dhule-Pimpalgaon (Km 265.00 to Km 380.00) section of NH-3 in the State of Maharashtra - Proposal of Maharashtra Jeevan Pradhikaran, Nashik for Crossing Water Supply Pipeline at Km. 330.070 across NH-3.

Maharashtra Jeevan Pradhikaran, Nashik vide letter cited above has submitted proposal for Crossing Water Supply Pipeline across NH-3 (Dhule-Pimpalgaon) section of NH-3 for approval of the Competent Authority, Highway Administration.
