Sub: NHAI, Madurai Region - PIU, Tuticorin - Operation and Maintenance of 4 laning of Madurai - Aruppukottai section from Km 138/800 to Km 266/865 of NH-45B in the State of Tamil Nadu - NOC for erection of 33 KV Overhead Line (i) along from Km 196/534 to Km 196/567 (RHS) & (ii) Across at Km.196/567 by M/s Velan Infra Projects (P) Ltd.

The proposal received from PD, Tuticorin vide reference cited above recommending for issuing NOC for erection of 33 KV Overhead Line in Kodangipatti village

- i. along highway from Km 196/534 to Km 196/567 (RHS)&
- ii. Across highway @ Km.196/567 on Madurai-Aruppukottai section of NH-38 (Old No. NH-45B) M/s Velan Infra Projects (P) Ltd.
- 2) The instant proposal has been examined in light of Ministry's latest guidelines dated 22.11.2016 and the following are brought out;

The alignment proposed by M/s Velan Infra Projects (P) Ltd, Chennai is proposing to erect Over Head Line as hereunder:

3. The right of Overhead Line at the edge of the ROW for a length of 33 m along National Highways. The erection of 33 KV overhead line on RSJ pole is proposed to be laid at a distance of 15.0m from the edge of Shoulder, which is in

- conformity with Ministry's guidelines vide letter no. NHIII/ P/ 66/76 dated 19.11.1976.
- 4. The M/s Velan Infra Projects (P) Ltd, Chennai has furnished an undertaking to the effect that they w way is 60 m in the aforesaid stretch. The Applicant proposed to erect 33 KV ill remove the erected 33 KV overhead line in future if required by NH Authority at any time for expansion of the NH at their own cost without claiming any compensation from NHAI. Also, certified that, the proposed erection of 33KV Overhead line work will not affect the design, stability, traffic safety and future improvement of the proposed stretch.
 - 5. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/ S&R (R) dated 22.11.2016 the relaxation application submitted by the applicant will be made available for public comments and the comments may be invited within 30 days from the day of uploading.
