**Sub:** NHAI-PIU-NSK - Road Safety Improvement Works on **Ghoti-Sinnar** section from Km. 0+000 to Km. 53+500 on NH-160A in the State of Maharashtra - **MSEDCL, Nashik's Proposal for 2 Nos. of Crossing of Underground 33 KV & 11 KV XLPE Electrical Cable of New Bharvir Substation in Nashik Rural Division under MSKVY 2.0 Scheme across NH-160A.**

Executive Engineer (O&M), MSEDCL, Nashik vide letter cited above has submitted Proposal for 2 Nos. of Crossings of Underground 33 KV & 11 KV XLPE Electrical Cable across with (Ghoti-Sinnar Section) of NH-160A for approval of the Competent Authority, Highway Administration.

2. From the submitted proposal, it is observed that, the Crossings Underground Electrical Line is proposed across Ghoti-Sinnar Section at 3 locations across NH-160A (between Ch. 33 - Ch. 34 and between Ch. 27 - Ch. 28).

As per Para-4 of Ministry of Road Transport & Highways (MoRT&H) Circular No. RW/NH-33044/29/2015/S&R(R), Dtd. 22.11.2016, the Highway Administration shall put out in the Public Domain for 30 days for seeking claims and objections (On grounds of Public inconvenience, safety and general public interest).
