## Invitation of Public Comments

**Sub:** NHAI, RO Jammu-PIU Jammu- NOC FOR LAYING OF SEWER LINE ALONG SERVICE ROAD FROM TOYOTA SHOWROOM AT NARWAL TO QASIM NAGAR CROSSING JAMMU FOR THE SCHEME TREATMENT OF 5 NALLAHS FALLLING ON LEFT BANK OF RIVER TAWI UNDER AMRUT, GOVT OF INDIA- REGARDING.

The proposal is regarding laying of Sewer Line Along Service Road from Toyota Showroom at Narwal To Qasim Nagar Crossing Jammu for the scheme treatment of 5 Nallahs fallling on Left Bank of River Tawi Under Amrut, Govt Of India on Jammu Byepass section in the UT of Jammu &Kashmir was submitted to this office by PD PIU Jammu letter No. PD,PIU Jammu letter No. 11022/1/2017/PIU-JMU/J-U/1668 dt 16.06.2020 & 11022/1/2017/PIU-JMU/J-U/1926 dt 13.07.2020 in accordance with Ministry guidelines dated 22.11.2016.

2. Executive Engineer, Sewerage & Drainage Div (West), Jammu intends to lay sewer line from Km. 7.270 to 7.741 (RHS) i.e. from Toyota Showroom at Narwal To Qasim Nagar Crossing Jammu at extreme edge of NHAI Right of Way (ROW) beyond drain.

3. The submitted proposal is in conformity with Ministry's latest guidelines dated 22.11.2016 regarding accommodation of public and industrial utility services along and across National Highways.

4. Executive Engineer, Sewerage & Drainage Div (West), Jammu (UEED) has furnished an Undertaking to the effect that they will shift the pipeline if required at any time owing to expansion of the road or if necessary by the NH Authority at his own cost and risk without claiming any cost from NHAI. Further, they have furnished an undertaking that not to damage other utility, if damaged then to pay the losses either to NHAI or to the concerned agency. The applicant has undertaken to indemnify against all damages and claims by NHAI. Also, certified that the proposed laying of pipeline will not have any deleterious effect on any of the bridge components and road way safety for traffic.
