Sub: NHAI, RO Jammu-PIU Jammu- PERMISSION FOR LAYING OF 300 MM DIA WATER SUPPLY PIPELINES OF MES UDHAMPUR FROM SANGOOR VILLAGE TO SHANKAR VILLAGE FROM KM. 14+290 TO KM. 15+360 FOR ACCOMODATING PUBLIC UTILITY SERVICES - REGARDING

The proposal is regarding laying of 300 mm dia water supply pipelines of MES Udhampur from Sangoor village to Shankar village from km. 14+290 to km. 15+360 for accommodating public utility services on Jammu Udhampur section in the UT of Jammu & Kashmir was submitted to this office by PD PIU Jammu letter No. PD,PIU Jammu letter No. 11022/1/2017/PIU-JMU/J-U/68 dt 08.01.2020, Jammu letter No. 11022/1/2017/PIU-JMU/J-U/210 dt 24.01.2020, letter No. 11022/1/2017/PIU-JMU/J-U/3941 dated 03.11.2020 & letter No. 11022/1/2017/PIU-JMU/J-U/4022 dated 17.11.2020 in accordance with Ministry guidelines dated 22.11.2016.

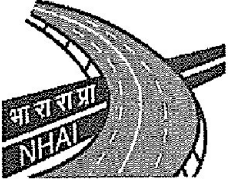
2. Garrison Engineer(U), MES Udhampur intends to lay 300 mm dia water supply pipelines of MES Udhampur from Sangoor village to Shankar village from km. 14+290 to km. 15+360 for accommodating public utility services on Jammu Udhampur section

3. The submitted proposal is in conformity with Ministry's latest guidelines dated 22.11.2016 regarding accommodation of public and industrial utility services along and across National Highways.

4. Garrison Engineer(U), MES Udhampur has furnished an Undertaking to the effect that they will shift the pipeline if required at any time owing to expansion of the road or if necessary by the NH Authority at his own cost and risk without claiming any cost from NHAI. Further, they have furnished an undertaking that not to damage other utility, if damaged then to pay the losses either to NHAI or to the concerned agency. The applicant has undertaken to indemnify against all damages and claims by NHAI. Also, certified that the proposed laying of pipeline will not have any deleterious effect on any of the bridge components and road way safety for traffic.
