Sub: NHAI, RO Jammu-PIU Jammu- PERMISSION FOR INSTALLATION OF TELECOM TOWER AT KM. 22+700 (LHS) AS PER REQUIREMENT FOR LEASE LINE IN THE PREMISES OF BANN TOLL PLAZA - REGARDING

The proposal is regarding installation of telecom tower for lease line in the premises of Bann Toll Plaza on Jammu-Udhampur section in the UT of Jammu &Kashmir was submitted to this office by PD PIU Jammu letter No. 11022/1/2017/PIU-JMU/J-U/619 dt 26.02.2021 in accordance with Ministry guidelines dated 22.11.2016.

- 2. M/s Reliance Jio Infocomm Limited intends to install the telecom tower for lease line in the premises of Bann Toll Plaza on Jammu-Udhampur section in the UT of Jammu & Kashmir
- 3. The submitted proposal is in conformity with Ministry's latest guidelines dated 22.11.2016 regarding accommodation of public and industrial utility services along and across National Highways.
- 4. Shri Lokesh Mandla, Real Estate Manager, M/s Jio Infocomm Limited has furnished an Undertaking to the effect that they will shift the tower if required at any time owing to expansion of the road or if necessary by the NH Authority at his own cost and risk without claiming any cost from NHAI. Further, they have furnished an undertaking that not to damage other utility, if damaged then to pay the losses either to NHAI or to the concerned agency. The applicant has undertaken to indemnify against all damages and claims by NHAI.
- 5. As per the guidelines issued by the Ministry vide letter No. RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by Shri Lokesh Mandla, Real Estate Manager, M/s Jio Infocomm Limited will be made available for public comments/objections and the comments will be invited within 30 days from the date of uploading.
