Invitation of Public Comments

Sub: NHAI, RO Jammu-PIU Jammu- Permission for laying sewer line for the work "Complete Survey, Design and Construction of 3 No. Sewerage Treatment Plants, Sewerage Network and allied works for Pollution Abetments of Rivers Devika and Tawi at Udhampur Town (Jammu & Kashmir) under National River Conservation Plan including operation and maintenance for 10 years"- Reg.

The proposal is regarding laying sewer line for the work "Complete Survey, Design and Construction of 3 No. Sewerage Treatment Plants, Sewerage Network and allied works for Pollution Abetments of Rivers Devika and Tawi at Udhampur Town (Jammu & Kashmir) under National River Conservation Plan including operation and maintenance for 10 years" has been submitted to this office by PD PIU Jammu letter No. 11022/1/2017/PIU-JMU/J-U/2133 dt 06.08.2021 & 11022/1/2017/PIU-JMU/J-U/3352 dt 24.12.2021 in accordance with Ministry guidelines dated 22.11.2016.

2. Executive Engineer, Sewerage & Drainage Div (West), Jammu intends to lay the sewerage line & Pumping station (10.06m x10.06m) , from Km. 12+200 to Km. 15+200 (LHS) Udhampur Bypass at extreme edge of NHAI Right of Way (ROW).
3. The submitted proposal is in conformity with Ministry's latest guidelines dated 22.11.2016 regarding accommodation of public and industrial utility services along and across National Highways.
4. Executive Engineer, Sewerage & Drainage Div (West), Jammu has furnished an Undertaking to the effect that they will shift the sewer line if required at any time owing to expansion of the road or if necessary by the NH Authority at his own cost and risk without claiming any cost from NHAI. Further, they have furnished an undertaking that not to damage other utility, if damaged then to pay the losses either to NHAI or to the concerned agency. The applicant has undertaken to indemnify against all damages and claims by NHAI.
