Invitation of Public Comments

Sub: NHAI, PIU, Coimbatore - Rehabilitation and Up-gradation of NH-209 from km 123.550 to Km. 150.400 of Dindigul - Bangalore Road (Pollachi to Coimbatore Section) to four lane with paved shoulder in the State of Tamilnadu under NHDP-IV on EPC Basis - Request for permission to lay underground Optical Fiber Cable (OFC) on NH-209 along the Road from km 130/850 to km 132/420 (RHS), km 131/340 to km 131/620 (LHS) for a length of 1850 meters and also Crossing at km 131/620 & km 132/420 on Pollachi to Coimbatore Section in the State of Tamil Nadu-Reg.

1. The proposal is regarding permission for laying of public utility - Optical Fiber Cable (OFC) in the above said project chainages along the road for a length of 1850 meters by Open trench/ HDD method as per site condition and Crossing at km 131/620 & km 132/420 by M/s. Bharti Airtel Limited, Chennai.
2. M/s.Bharti Airtel Limited, Chennai has furnished an undertaking to accept any claims raised by the Authority, if any and the same will be paid by them and also furnished undertaking not to damage other utility, if damaged, then to pay the losses either to NHAI or to the concerned agency.
3. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/ S&R(R) dated 22.11.2016, the proposal submitted by M/s. Bharti Airtel Limited Chennai, will be made available for 30 days seeking public comments/objections and the comments shall be furnished within 30 days from the day of closure of public objections.
