Sub: NHAI - PIU, Salem - permission for erecting HT Electrical poles along the National Highway - 44 (Seshampatti to Pagalahalli) at the edge of ROW / Utility corridor from Km 148.600 to Km 150.500 (LHS) - 1.9 Km in Dharmapuri District of Tamilnadu State - Approval requested - Reg

- 1). The subject proposal is requesting permission for erecting HT Electrical poles (60 Nos of RCC poles 9m height) along the National Highway 44 (Seshampatti to Pagalahalli) at the edge of ROW / Utility corridor from Km 148.600 to Km 150.500 (LHS) 1.9 Km in Dharmapuri District in the project of Krishnagiri Thumbipadi section of NH-7 in the State of Tamil Nadu.
- 2). The Executive Engineer, O&M, TANGEDCO, Dharmpuri has furnished an undertaking to move the utility line for any work of improvement or repairs to the road, if NHAI considers if necessary in future, it will be carried out as desired by the NHAI at their cost within a reasonable time (not exceeding 90 days) of the intimation given. Further, the applicant has furnished the undertaking for payment of rent / fee as mentioned in the Ministry's Circular No.RW/NH-33044/29/2015-S&R dated 22.11.2016 as when asked by NHAI.
- 3). As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by The Executive Engineer, O&M, TANGEDCO, Dharmpuri will be made available for 30 days seeking public comments / objection and shall be furnished within 30 days from the day of closure of public objections.
