
- 1). The subject proposal is requesting permission for laying of water pipe line along the NH-47 by open excavation of 600mm Dia pipe from Km 39/075 to Km 39/090 - 15m (RHS), Km 41/560 to Km 41/575 - 15m (RHS) and 700mm Dia MS casing with 600 mm dia DI pipe line by HDD Method across NH at Km 39/090 - 60m and Km 41/575 - 60m in the project of Salem - Kumarapalayam section of NH-47 in the State of Tamil Nadu.
- 2). The Secretary, Morepalayam Suttruvattara Lift Irrigation Agriculturists Society, Namakkal has furnished an undertaking to move the utility line for any work of improvement or repairs to the road, if NHAI considers if necessary in future, it will be carried out as desired by the NHAI at their cost within a reasonable time (not exceeding 90 days) of the intimation given. Further, the applicant has furnished the undertaking for payment of rent / fee as mentioned in the Ministry's Circular No.RW/NH-33044/29/2015-S&R dated 22.11.2016 as when asked by NHAI.
- 3). As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by the Secretary, Morepalayam Suttruvattara Lift Irrigation Agriculturists

Society, Namakkal will be made available for 30 days seeking public comments / objection and shall be furnished within 30 days from the day of closure of public objections.
