Sub: NHAI – PIU, Salem – Proposal of laying the PVC water pipe line for agriculture purpose by open excavation along the NH-47 from Km 30/994 to Km 31/025 – 62m (LHS & RHS) and across the road by HDD Method at Km 30/994 – 60m and Km 31/025 - 60m by the President, M/s.Sree Sivasakthi Neeratru Paasana Vivsaigal Sangam, Sankagiri - Approval requested – Reg

- 1). The subject proposal is requesting permission for laying of PVC water pipe line for agriculture purpose along the NH-47 by open excavation of 400mm & 315mm Dia pipe from Km 30/994 to Km 31/025 62m (LHS & RHS) and 1200 mm dia MS casing dia with 315mm and 400mm dia water line by HDD Method across NH at Km 30/994 60m and Km 31/025 60m in the project of Salem Kumarapalayam section of NH-47 in the State of Tamil Nadu.
- 2). The President, M/s.Sree Sivasakthi Neeratru Paasana Vivsaigal Sangam, Sankagiri has furnished an undertaking to move the utility line for any work of improvement or repairs to the road, if NHAI considers if necessary in future, it will be carried out as desired by the NHAI at their cost within a reasonable time (not exceeding 90 days) of the intimation given. Further, the applicant has furnished the undertaking for payment of rent / fee as mentioned in the Ministry's Circular No.RW/NH-33044/29/2015-S&R dated 22.11.2016 as when asked by NHAI.
