Sub: NHAI – PIU, Salem – Proposal of laying the water pipe by open excavation along the NH-7 from Km 214/356 to Km 214/650 – 294m (LHS), Km 215/590 to Km 215/960 – 370m (RHS) and across the road by HDD Method at Km 214/650– 60m, by the Executive Engineer, TWAD Board, RWS Division, Salem - Approval requested – Reg

- 1). The subject proposal is requesting permission for laying of water pipe line along the NH-7 by open excavation of 300mm Dia pipe from Km 214/356 to Km 214/650 294m (LHS), 250mm dia from Km 215/590 to Km 215/960 370m (RHS) and 457 mm dia MS casing with 300mm dia water line by HDD Method across NH at 214/650 60m in the project of Thumbipadi Namakkal section of NH-7 in the State of Tamil Nadu.
- 2). The TWAD Board, Salem has furnished an undertaking to move the utility line for any work of improvement or repairs to the road, if NHAI considers if necessary in future, it will be carried out as desired by the NHAI at their cost within a reasonable time (not exceeding 90 days) of the intimation given. Further, the applicant has furnished the undertaking for payment of rent / fee as mentioned in the Ministry's Circular No.RW/NH-33044/29/2015-S&R dated 22.11.2016 as when asked by NHAI.
- 3). As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by M/s TWAD Board, Salem will be made available for 30 days seeking public comments / objection and shall be furnished within 30 days from the day of closure of public objections.
