Sub: Proposal for grant of permission for laying Optical Fiber Cable (OFC) along NH-361 on Nagpur - Wardha Road from the following sections km 478/700 to km 480/200 Left Hand Side of the Road (LHS) along the Road for a total length 1.500km in the state of Maharashtra.

It is to inform all concern that M/S Reliance Jio Inforcomm Limited vide letter under reference (ii) has submitted a proposal for the subjected work and PD, NHAI, PIU, Yavatmal has recommended the above proposal vide letter under reference (i) for approval of the Competent Authority / Highway Administrator.

2. The alignment proposed by that M/S Reliance Jio Inforcomm Limited along NH-361 from km. 478/700 to km 480/200 for the total length 1.500 km. In the state of Maharashtra is as follows:

- To lay Optical Fiber Cable (OFC) from km 478/700 to km 480/200 (LHS) along the NH-361 in utility duct.
- The cross the highway at Ch. km 479/200 using HDD method.

3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).

4. In view of the above, the comments / objections of affected public is hereby invited with reference to the Ministry's circular dated 22.11.2016 due to above underground line on the subjected stretch.
