


## **Invitation of Public Comments**

Sub: Proposal for grant of permission for laying Optical Fiber Cable (OFC) along NH-361 on Nagpur – Wardha Road from the following sections kn\*477/600 to km. 479/200 Right Hand Side of the Road (RHS) along the Road for a total length 1.600km in the state of Maharashtra.

It is to inform all concern that M/S Reliance Jio Inforcomm Limited vide letter under reference (ii) has submitted a proposal for the subjected work and PD, NHAI, PIU, Yavatmal has recommended the above proposal vide letter under reference (i) for approval of the Competent Authority / Highway Administrator.

- 2. The alignment proposed by that M/S Reliance Jio Inforcomm Limited along NH-361 from km. 477/600 to km. 479/200 for the total length 1.600 km. In the state of Maharashtra is as follows:
  - To lay of cable along NH-361 in trench from km 477/600 to km. 479/200 (RHS) at edge of ROW with depth of 1.65m.
  - The cross the road at Ch. km 479/200 using HDD method.
- 3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
- 4. In view of the above, the comments / objections of affected public is hereby invited with reference to the Ministry's circular dated 22.11.2016 due to above underground line on the subjected stretch. The objections / comments may be addressed to the below mentioned address upto 17.06.2021, beyond due date, no comments/ objections will be accepted.
