Subject:- Permission proposal for laying 198 MW wind power plant overhead feeder with pole for 400/230KV utility services Across the road by single circuit panther at Km 83/130 & Km 84/855 of NH-81 (Coimbatore-Karur-Tiruchirappalli Chidambaram road) Karur District in the state of Tamil Nadu by M/s TP Vardhaman Surya Limited- Regarding.

The proposal is regarding request for permission for laying 198 MW wind power plant overhead feeder with pole for 400/230KV utility services Across the road by single circuit panther at Km 83/130 & Km 84/855 of NH-81 (Coimbatore-Karur-Tiruchirappalli Chidambaram road) Karur District in the state of Tamil Nadu by M/s TP Vardhaman Surya Limited submitted to this office by the SE (NH), Madurai vide letter No. 236/2024/JDO-1/NH dated 10.02.2025. The proposal has been examined and the details are as under:

2. The Right of Way in the stretch of NH proposed for laying 198 MW wind power plant overhead feeder with pole for 400/230KV utility services is varying from 33.40m to 23.50m. The carriageway width of stretch from Km 83/130 & Km 84/855 of NH-81 is 16.20m. M/s TP Vardhaman Surya Limited has proposed to laying 198 MW wind power plant overhead feeder for 400/230KV utility services Across the road by single circuit panther the Right of Way will be 16.00m above the carriageway top as per the Ministry's guideline No. RW/NH-33044/29/2015/ S&R(R) dated 22.11.2016.

3. M/s TP Vardhaman Surya Limited has furnished an undertaking to the effect that they will remove the laid underground water pipe line in future if required by NH Authority/MoRTH, Government of India at any time for expansion of the NH at their own cost without claiming any compensation from NH Authority/MoRTH, Government of India and any right on the NH land. Further, mentioned that, M/s TP Vardhaman Surya Limited will also restore the ROW surfaces to its original condition soon after removal of

the utility. Also, certified that the proposed laying 198 MW wind power plant overhead feeder with pole for 400/230KV utility services work will not affect the design, stability, traffic safety and future improvement of the proposed stretch.

4. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/ S&R(R) dated 22.11.2016 the application will be made available for public comments and the comments will be invited within 30 days from the day of uploading the same in the web site of Ministry of Road Transport & Highways for public comments.
