Sub: Permission/NOC to lay 1.3 Km's of 4" Ø CS and 125mm MDPE pipeline on Moradabad Bareilly along RHS of NH-530 from Ch.249.600 (M/s Pachauri Filling Station) to Chainage No.250.900 (Pilibhit Bypass) permission/NOC to lay 2.1 Km's of 4" Ø CS Natural Gas pipeline on Bareilly - Shahjahanpur road along RHS from Ch.250.900 (Pilibhit Bypass) to Chainage 253.00 (M/s BPCL, NRO Nawdiyan Kurmiyan) permission/NOC to lay 5.0 Km's of 4" Ø CS Natural Gas pipeline on Moradabad - Bareilly along RHS of NH-530 from Ch.237.200 to Ch.242.200 (M/s Gangwar Fuels) in the state of Uttar Pradesh.

Applicant, Central U.P. Gas Limited vide letter no.CUGL/Proj/Bly/NOC/25-26/1 dt.21.08.2025 has submitted the proposal for laying of 1.3 Km's of 4" Ø CS and 125mm MDPE pipeline on Moradabad Bareilly along RHS of NH-530 from Ch.249.600 (M/s Pachauri Filling Station) to Ch.250.900 (Pilibhit Bypass), laying of 2.1 Km's of 4" Ø CS Natural Gas pipeline on Bareilly - Shahjahanpur road along RHS from Ch.250.900 (Pilibhit Bypass) to Chainage 253.00 (M/s BPCL, NRO Nawdiyan Kurmiyan), laying of 5.0 Km's 4" Ø CS Natural Gas pipeline on Moradabad - Bareilly along RHS of NH-530 from Ch.237.200 to Ch.242.200 (M/s Gangwar Fuels) in the state of Uttar Pradesh.
