Invitation of Public Comments

Sub: NHAI – PIU, Salem – Proposal for laying of underground Optical Fiber Cable (OFC) of 120mm Dia PLB pipe along the NH-68 from Km 51/000 to Km 51/200 (LHS) and across the road by HDD Method of 150mm Dia Casing pipe at Km 51/000 by M/s Jio Digital Fibre Private Limited, Chennai - Approval requested – Reg

- 1). The subject proposal is requesting permission for laying of underground Optical Fiber Cable (OFC) along the NH-68 by Open Excavation of 120mm Dia PLB pipe from Km 51/000 to Km 51/200 (LHS) and across the road by HDD Method of 150mm Dia Casing pipe at Km 51/000 in the project of Salem Ulundurpet section of NH-68 in the State of Tamil Nadu.
- 2). M/s Jio Digital Fibre Private Limited, Chennai has furnished an undertaking to move the utility line for any work of improvement or repairs to the road, if NHAI considers if necessary in future, it will be carried out as desired by the NHAI at their cost within a reasonable time (not exceeding 90 days) of the intimation given. Further, the applicant has furnished the undertaking for payment of rent / fee as mentioned in the Ministry's Circular No.RW/NH-33044/29/2015-S&R dated 22.11.2016 as when asked by NHAI.
- 3). As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by M/s Jio Digital Fibre Private Limited, Chennai will be made available for 30 days seeking public comments / objection and shall be furnished within 30 days from the day of closure of public objections.
